

ADDRESS OF THE PRESIDENT, MS REBECCA TRESTON QC, ON THE OCCASION OF THE EXCHANGE OF CHRISTMAS GREETINGS AT THE SUPREME COURT OF QUEENSLAND ON WEDENSDAY 12 DECEMBER 2018

MAY IT PLEASE THE COURT

The Christmas Greetings held at this time each year are generally a time of reflection of the year passed, and of hopes for the year to come.

But the Bar Association recognises that not all reflections are the same.

We also thank those same judges who, after long days in court, devote hours of their free time to community service, to professional development, and to school and sporting activities sometimes at the expense of the family and loved ones. The Bar Association sees your contribution and we value it.

May we also thank the judicial officers, and also the Bar's own members, who give hours of work every year in the pursuit of sensible and effective law reform. With your help, we are able to influence debate, and outcomes, for reforms to bail, juvenile detention, sentencing, compensation for historical sexual abuse, a bill or rights and so the list goes on. That sensible and informed contribution helps build a more productive relationship with government, leading to better outcomes for the people of this state.



The Bar Association is working hard to build a respectful and healthy dialogue with government on important matters of policy. We value that relationship. We thank the Attorney General for her cooperative and consultative approach in 2018.
